MSH POST EVALUATION RFP AWARD REPORT WASTE MANAGEMENT SERVICES: RFP 12.14.2021.476 January 7, 2022

In compliance with section 3-204.04 of the Mississippi Office of Personal Service Contract Review Rules and Regulations, we hereby offer the following summary. In response to the RFP listed above, MSH received two (3) vendor proposals. Proposals were submitted by Republic Services, Waste Management Services, and Waste-Pro USA, in evaluation order ranking from highest to lowest. The MSH Waste Management Services RFP Evaluation Committee, after thorough blind review, made the following summary determinations: (1) The proposal from Republic Services meet all RFP requirements, offered sufficient staffing levels, offered sufficient past performance history, and offered sufficient regulatory compliance and equipment levels to meet contractual requirements. Republic Services also proposed the lowest overall cost to perform the required services. (2) Waste Management Service's proposal meet all RFP requirements and provided adequate details in most service areas, the proposal meet all service level requirements and offered the second lowest pricing to provide services. (3) Waste-Pro USA was rated by the MSH Evaluation Committee to have submitted a proposal which did not provide sufficient detail of services to be provided and the vendor also proposed the highest pricing.

The eventual contract for these services shall include all terms, conditions, and scope of services specified in the original RFP document issued by MSH. The contract shall also include the terms and conditions of the MSH standard independent contractor agreement. Based on the above information, the MSH Waste Management Services Committee has determined and makes the recommendation that a contract should be awarded to the vendor that ranked highest in evaluation scoring, Republic Services. The Committee offers that based on pre-determined rating criteria, Republic Services has submitted the best overall proposal.
