The Mississippi State Hospital (MSH) Doctoral Internship in Health Services Psychology is generalist in nature, and it is grounded in the clinician-scholar model. MSH provides services to Mississippians who are experiencing a wide range of psychiatric difficulties. In terms of goodness of fit, successful applicants tend to be those who have gained experience in working with an array of diagnoses and conditions, have worked in publicly-funded psychiatric facilities, or who have a desire to receive comprehensive, generalist training in the mental health field. Applicants who are interested in working with an underserved, Severely Mentally Ill population are strongly encouraged to apply.
