The MSH internship program is generalist in nature, and it is grounded in the clinician-scholar model. Our hospital provides services to Mississippians who are experiencing a wide range of psychiatric difficulties. In terms of goodness of fit, successful applicants tend to be those who have gained experience in working with an array of diagnoses and conditions, have worked in publically-funded psychiatric facilities, or who have a desire to receive a comprehensive, non-specialist training in the mental health field.
